AGREED ORDER

On this day the matter was submitted to the Banking Commissioner (Commissioner) of the State of Texas for consideration and action, relating to Previsión Integral de Servicios Funerarios, S.A. de C.V., of Ciudad Juarez, Mexico (Previsión) and its affiliated company, La Paz Funeral Home, Inc., of El Paso, Texas (La Paz). This matter concerns the correction of violations of the *Texas Finance Code* and the assessment of an administrative penalty for the sale of prepaid funeral contracts (PFCs) without the required permit. The Texas Department of Banking (Department) and Respondents wish to enter an agreement regarding these issues according to the terms described below.

- 1. Respondents and the Department agree to comply with the terms of this Order and jointly request the Commissioner to dispose of this matter pursuant to the provisions of *Government Code* § 2001.056.
- 2. Respondents acknowledge that the Commissioner has jurisdiction over this matter pursuant to Texas Finance Code Chapter 154 and *Texas Government Code* §§ 2001.171 et seq., and that the Commissioner has the authority to issue this Agreed Order under *Texas Government Code* § 2001.056.
- 3. Salvador Perches Jr. owns or co-owns, and operates, a number of businesses involved in the funeral industry. These include Previsión, a Mexican company that sells PFCs in Ciudad Juarez, Mexico., and La Paz, which operates four funeral homes in the El Paso area under the names La Paz and Perches.

- 4. Under the authority of *Texas Finance Code* Chapter 154, the Department regulates the sale of PFCs in Texas. Neither La Paz nor Previsión have the permit required by *Texas Finance Code* § 154.101 to sell PFCs in Texas.
- 5. On March 3, 2015, the Department became aware of a PFC allegedly sold by Perches Funeral Home in El Paso, Texas. In response to the Department's subsequent inquiry, Previsión asserted that it had sold the contract through an agent, and provided information regarding other PFCs sold by Previsión.
- 6. Because information establishing where each PFC was sold would be substantially burdensome to obtain, Respondents and the Department agree for purposes of this Order that all PFCs listing a Texas address were sold in Texas and therefore should be regulated under *Texas Finance Code* Chapter 154. In accordance with this, the parties agree that there are 442 outstanding Texas PFCs.
- 7. Corrective actions that have been taken by Respondents are as follows. Previsión has ceased selling PFCs in Texas and has deposited all funds relating to the PFCs described in Paragraph 6, including an appropriate amount of interest, into trust at an approved financial institution. La Paz has applied for a restricted permit to administer the existing PFCs. Upon issuance of the permit, the parties intend to transfer the 442 PFCs listed in Attachment A from Previsión to La Paz for continued administration under the provisions of *Texas Finance Code* Chapter 154.
- 8. *Texas Finance Code* § 154.406 authorizes the Commissioner to assess administrative penalties in this matter. The imposition of an administrative penalty against Previsión in the amount of \$31,000.00 is appropriate and reasonable given the nature of the violations cited above.
- 9. Any violation of this Order could subject Previsión to additional regulatory or enforcement actions. Nothing in this Order diminishes the regulatory or enforcement powers of the Department, the Commissioner, the Finance Commission of Texas, or any other state agency, nor restricts the Department from using the facts of this matter, or other past matters that may come to light in the future, to establish a pattern or practice of repeated violations of law in future proceedings.
- 10. Previsión has been notified of the right to a hearing on the matter of administrative penalties under *Texas Finance Code* § 154.406.
- 11. For purposes of this proceeding, Previsión knowingly and voluntarily waives:
 - a. Service upon Previsión of this Agreed Order;
 - b. Notice and hearing prior to imposition of an administrative penalty;

- c. Review of this Agreed Order by the Texas Finance Commission, and judicial review of this Agreed Order as provided by *Texas Government Code* §§ 2001.171 et seq., and any other challenge to the validity of this Order.
- 12. Respondents and the Department agree to the factual findings, legal conclusions, and terms and conditions of this Agreed Order.

ORDER

WHEREFORE, based on the foregoing, the Commissioner ORDERS that this matter is resolved in accordance with the following terms:

- 13. Respondents affirm that to the best of Respondents' knowledge, no other PFCs exist which were sold in violation of *Texas Finance Code* Chapter 154. Previsión also affirms that it has not violated Chapter 154 in any other way.
- 14. No later than December 11, 2015, Respondents will contact all purchasers of PFCs that are currently past due, and offer each purchaser one of the following options:
 - a. A full refund of amounts already paid;
 - b. The opportunity to make sufficient payment to bring the contract current; or
 - c. Conversion of the PFC to an insurance-funded PFC, involving a full refund of amounts already paid and the execution of a new insurance-funded PFC using the refunded amount.
- 15. After December 11, 2015, all funds held for past due PFCs must be handled pursuant to Texas escheat law and subject to the authority of the Texas Comptroller.
- 16. Because substantially all PFCs involved in this matter were written in Spanish, if the Department is ever unable to ascertain the goods and services involved in a particular PFC, Respondents shall provide translation services.
- 17. Previsión shall pay an administrative penalty of \$31,000.00. The administrative penalty shall be paid in full to the Department no sooner than September 2, 2015, but no later than September 30, 2015.
- 18. Nothing in this Order guarantees the issuance of a permit. Provided that a permit is issued to La Paz, La Paz agrees to maintain and administer the 442 PFCs described in Paragraph 6, as listed in Attachment A, in accordance with the provisions of *Texas Finance Code* Chapter 154.
- 19. This Order is effective on the date signed by the Commissioner.
